Our State Senator Saddam Salim put forward a bill to require all Virginia to allow accessory dwelling, attached and detached. If the measure passes the House and is signed by the Governor, Falls Church would have to work within state-mandated guidelines.



Falls Church's Black History: A Welcoming Community That Has Not Always Been So Welcoming

City staff proposed the addition of Tinner Hill as a Cultural and Historic District in the City's Comprehensive Plan. No zoning or tax changes are expected. Read about the historic sites that will be included in this district.




<u>The Greening of Lincoln – A Stormwater Project</u>

This \$8m Greening of Lincoln addresses flood risks, sidewalk and traffic safety issues on Lincoln Avenue. The street will be narrowed, speed reduced, and sidewalk widened. Several parking areas will become bioretention areas. This post includes the proposed design and maps to explain the vulnerability of the area to flooding and excessive stormwater runoffs.



Senate Bill SB 304 on Accessory Dwelling Units: How would it affect Falls Church?

Senate bill SB 304 proposes to mandate that all localities in Virginia allow accessory dwelling units in residential districts, whether internal, attached or detached, with minimum side and rear setbacks, overriding the ability of communities to decide zoning issues for themselves. If passed in Richmond and signed into law, Falls Church will be required to follow those guidelines in modifying its current regulations on internal accessory dwellings and devising any new ordinance on detached accessory dwellings. This analysis examines how it might be constrained.



2024 Economic Development Authority Appointments and Updates on Mixed-Use Developments, Virginia Village, New Businesses

For 2024, the EDA re-elects developer Bob Young chair. City Council chose to re-appoint past members despite having well-qualified residents offer their services. In their first meeting of the year, there were updates on Virginia Village property acquisitions, anticipated new businesses and a new 7-story mixed-use development.
