

Dear Neighbors,

Following presentation of the Economic Development Authority's annual report to City Council at the end of May, two Council members asked the EDA to be particularly sensitive to the appearance of conflicts of interest by members in their professional and volunteer City roles. Council Members Erin Flynn and David Snyder also requested guidance from the City Attorney to ensure all elements of Falls Church government meet the highest standards in this area. Their comments prompted a strong response from EDA Vice Chair Ross Litkenhous. We cover the exchange between the Council members and Mr. Litkenhous and a subsequent statement from Ms. Flynn.

The City is evaluating what the staff characterizes as "a small fix" that would reduce parking requirements for new business tenants locating in smaller, older buildings. The City Council initially approved the proposed change, sending it to the Planning Commission, other boards and commissions, and the Falls Church Chamber of Commerce for review. Our post describes the suggested parking rule amendment as well as concerns from some Planning Commissioners of "unintended consequences." The Planning Commission will hold a public hearing on the ordinance change at its June 26 meeting.

Former Citizens Advisory Transportation Committee Member Andrew Oleson describes the history and current status of the 2024 Bicycle Master Plan. The City will hold public meetings on the bike plan on June 20, 25 and 27.

Members of the Falls Church Climate Action Network introduce their group and suggest how we can all do our part in reducing our energy footprint with links to many resources including the City's One-Stop Shop for Community Energy Action. FCCAN is holding an "Electrify FC" Open House on June 22.



Another Proposed Mixed-Use Apartment Project

Commissioner Derek Hyra cautioned Mr. Litkenhous to avoid a conflict of interest.



<u>CACT Analysis of Traffic Crashes In</u> <u>Falls Church City</u>

Injuries from traffic crashes jumped by 50% in 2023 compared to 2022. 203 injuries were reported in the last 10 months. This analysis looks at the data behind these numbers and some possible remedies to make our roads safer.



<u>OakPark Townhomes –</u> <u>The First T-Zone Project on Park</u> <u>Avenue</u>

OakPark Townhomes is the first to take advantage of the new T-Zone ordinance, with the maximum density and size allowed. EDA Chair Bob Young owns the lots and partnered with Madison Homes to bring this project to the City.



A Quinn Homestretch Primer
